Recent discussions were focused on creating appealing events while complying with the anticipated restrictions. The Eastern National Meet is still scheduled for Oct. 20-24

in Morgantown, Pennsylvania, and will be hosted by the Philadelphia Region. Let's hope that these meets are held, and we can enjoy Lincolns and good friends.
